

**Terms, Conditions and Rules (the "Official Rules") for the
Brenton Hunt Spec Giveaway (the "Sweepstakes")**

All entrants must read these Official Rules before entering the sweepstakes.

This Sweepstakes is governed by the laws of the State of Michigan, and all claims must be resolved in the federal or state courts located in Michigan.

1. Eligibility. Eligibility is limited to only legal residents of the 49 United States and the District of Columbia (Rhode Island excluded) who have reached the age of majority (as defined by the law of the state in which entrant resides) as of 9/20/2017.
